Duties and Responsibilities:

ATHLETE DEVELOPMENT:

Responsibilities include but are not limited to:

- Commitment to player development. Must have a plan for teaching fundamentals and a progression for skill development.
- Monitor the academic progress of all players in the program.
- Must be able to effectively prepare the team for games through scouting, practice, and analysis of statistical information.
- Maintain accurate records of student eligibility (physical on file, academic eligibility, transfer students, Athletic Code of Conduct, etc.)
- Coordinate postseason awards for the program.
- Develop and administer camp experiences for K-8 students.
- Assist student-athletes in transitioning to post-secondary athletics, including providing information about eligibility and recruiting.
- Works to ensure the student-athlete experience is well-rounded and focused on athletics, academics, and character development.

Skills/Requirements:

PERFORMANCE RESPONSIBILITIES:

Responsibilities include but are not limited to:

Coordinates all activities related to successfully running a large high school girls basketball program in a first-class manner. Processes and procedures related to girls' basketball and coaching operations are reviewed regularly and revised to ensure operational activities are fluid, efficient, and support the overall program.

- Commitment to building positive relationships with players, parents, and the community.
- Ability to be an appropriate role model for students.
- Good communication skills, including utilization of technology.
- Ability to develop an organized program. Must be able run organized practices, off-season workouts, conditioning, youth leagues, summer camps, parent meetings, among other duties not listed.
- Ability to maintain the budget through adherence to the purchasing and fundraising policies of the school.
- Strictly adhere to the school's policies and procedures.
- Has knowledge of and will adhere to IHSAA rules and regulations.
- Will be able to manage all aspects of the girls' basketball program.
- Must be able to build and supervise a cohesive coaching staff.
- Must be able to work collaboratively with administration, fellow coaches, and support staff.
- Maintain equipment inventory.
- Be familiar with all IHSAA materials and enforce all IHSAA rules and regulations in the sport of girls' basketball.
- Uphold the school athletic code in a fair and consistent manner that is within the intent of the code. Ensure district adherence to all IHSAA and district policies, administrative rules, procedures, and codes relating to and participation in athletics. Work cooperatively with school administration to enforce school rules related to athletic participation. Other duties as assigned by the athletic director and/or principal.
